- The DepEd Schools Division Sorsogon Province, through the FY 2022 OSEC-5-22-7203 intends to apply the sum of Seven Hundred Nine Thousand Eight Hundred Twenty-Five Pesos (Php 709,925.00) being the ABC to payments under the contract for PURCHASE OF SPORT SUPPLIES AND EQUIPMENT ENHANCEMENT AND DISTRIBUTION (SSEED) PROGRAM - REBID, Project No. 22-11-003. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *DepEd Schools Division Sorsogon Province* now invites bids for the above Procurement Project. Delivery of the Goods is required by *Fifteen (15) days upon receipt of Notice to Proceed.* Bidders should have completed, within 2 *years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a

country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from *DepEd*, *Schools Division of Sorsogon (Province)*, *Balogo Sports Complex, Sorsogon City* and inspect the Bidding Documents at the address given below during *office hours*, (8:00am to 5:00pm).
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on **December 5, 2022 to December 13, 2022** from the given address and PhilGEPS website and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos Only (Php 1,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person not later than the submission of their bid.

contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
