# ADMINISTRATION OF THE REGULAR PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT)

- 1. Pursuant to Regional Memorandum No. 01455, S. 2025, this Office would like to inform all qualified and interested learners and their parents, and all public and private school personnel that the Regular Philippine Educational Placement Test (PEPT) shall be administered in December 2025 at Gubat National High School. Final schedule of the Regular PEPT administration shall be disseminated through a separate issuance.
- The PEPT is a nationally administered assessment intended for learners in special circumstances who need to access or resume schooling and/or obtain certification of completion by grade level.

3. The target registrants for the PEPT include, but are not limited to, the following categories of learners:

- 4. The following registration guidelines must be strictly observed by all concerned:
  - Registration Period: Registration shall commence immediately
    upon the publication of this Memorandum until one week before the
    test administration. The specific date of the test administration will be
    announced in a separate advisory.
  - Registration Fee: No test registration fees shall be collected from the registrants.
  - Capacity Limit: This Division is allocated with 182 test materials, and hence, will accept the first 182 registrants. Once the maximum limit is reached, registrants shall be redirected to a designated nearby division with remaining slots.
  - No Walk-in Policy: A strict No Walk-in policy shall be implemented on the day of the test administration.
  - Non-readers are not eligible to take the test.
- 5. All interested and qualified registrants are advised to submit the documentary requirements to the Guidance Office of any public or private schools where they are connected. From the release of this memorandum until a week before the test administration, Mondays through Fridays (excluding holidays) from 8:00am-4:00pm. Below are the requirement for specific types of test registrants.

#### 5.1 For new test-takers:

- 6.1.1 Original and one photocopy of the **birth certificate** duly authenticated and issued by the Philippines Statistics Authority (formerly National Statistics Officer) or by the Local Civil Registrar.
- 5.1.2 Certified True Copy and one photocopy of the **permanent school record** e.g. SF10/Form 137, School Report Card/ECCD/Checklist/Diploma

5.1.3 **Certificate of attendance in intervention programs,** or any proof of schooling (if applicable)

5.1.4 Two identical and recently taken 1x1 colored **ID pictures** with name tags

5.1.5 One copy of the accomplished **PEPT Registration Form** (accessible via: https://bit.ly/BEARegularPEPT)

#### 5.2 For test retakers and PEPT Passers:

5.2.1 Original and one photocopy of the **PEPT Certificate of Rating** (for applicants who need to retake a PEPT subtest)

5.2.2 Two identical and recently taken 1x1 colored ID pictures with

name tags

- 5.2.3 One copy of the accomplished **PEPT Registration Form** (accessible via: <a href="https://bit.ly/BEARegularPEPT">https://bit.ly/BEARegularPEPT</a>)
- 6. The placement of the special PEPT qualifiers shall take effect in the next or subsequent year, not during the current school year when the test was administered, pursuant to Section 6 (Grade Level Placement Assessment) of DepEd Order No. 55, s 2016 titled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program.
- 7. Examinees whose test score in one subject is lower than 75% may be allowed to retake the failed subtest within six months from the date of examination. On the other hand, examinees whose test scores in two or three subject areas are lower than 75% are required to retake all the subjects.
- 8. School Heads and District Supervisors are enjoined to disseminate this Memorandum widely and refer interested learners and their guardians to the Division Testing Coordinator for the official registration process.
