ADMINISTRATION OF DLP PRE-TEST ASSESSMENT

1. Pursuant to **Regional Memorandum CLMD-2025-0225**, titled "*The Conduct of the Dynamic Learning Program (DLP) Pre-Test Assessment*", this Office hereby informs all concerned that the schedule for the administration of the Dynamic Learning Program (DLP) Pre-Test Assessment will be on **November 27-28, 2025**.
2. All identified schools (Treatment and Control Category) for the conduct of the DLPA shall administer the DLP pre-test assessment on the scheduled dates. Further, school Heads and designated testing personnel are reminded to ensure strict adherence to testing protocols, proper handling of assessment materials, and timely submission of test administration reports.
3. The Pre-Test Assessment of DLP shall be prioritized. Therefore, the Cluster INSET schedule of the identified schools shall be moved on a later date. Due to time constraints, the DLP pre-test assessment will be conducted over **2 days** for **Grades 7-10**. Teachers of the identified schools will **form part of the Test Administrators**, in addition to the two designated Test Administrators. School Heads must ensure proper **orientation** of all teachers who will work as Test Administrators.
4. The selected testing personnel involved in the administration of the DLP Pre-Test Assessment for Pilot School Heads for both Control and Treatment groups shall be those indicated in the enclosure of this Advisory.
5. The **DLP Pre-Test Assessment Forms, Testing Administrators (TA) Manuals, School Head Manuals**, and other necessary testing materials are made available through the following Google Drive link:
