**DISSEMINATION OF THE NATIONWIDE POSTER-MAKING CONTEST IN  
CELEBRATION OF THE 125TH ANNIVERSARY OF THE SUPREME COURT**

1. In corollary to **Regional Memorandum No. 00085, s.2026** and to the **Memorandum issued by the Office of the Undersecretary for Governance and Operations, Department of Education**, relative to the conduct of the **Nationwide Poster-Making Contest in celebration of the 125th Anniversary of the Supreme Court of the Philippines**, this Memorandum is hereby issued for the information and guidance of all concerned.
2. The activity, with the theme “Imagine a Just World,” is open to all enrolled Elementary School learners nationwide and aims to promote civic awareness and appreciation for the rule of law by encouraging learners to artistically depict the role of the Judiciary in promoting justice, equality, and community well-being.
3. The following are the salient guidelines:

**Eligibility:**

- a) Open to all enrolled Elementary School learners
- b) Only one (1) entry per school shall be submitted

**Contest Timeline:**

- a) January 2026 – Launch and dissemination of guidelines
- b) Third week of January 2026 – Start of online submission
- c) February 28, 2026 – Deadline for submission of entries
- d) March 2026 – Initial screening of entries
- e) April 2026 – Announcement of Top 20 Finalists
- f) May 2026 – Final presentation and judging

g) June 2026 – Poster Exhibit and Awarding Ceremony

**Submission and Mechanics:**

- a) Entries shall be submitted through the official online platform to be announced by the Supreme Court.
- b) Posters must be original, created specifically for the contest, and must not bear any identifying marks such as the learner's name or school logo.
- c) AI-generated images, stock images, collages, and framed or mounted works are strictly prohibited.

**Awards:**

- a) The Top 20 finalists will be featured in a special exhibit at the Supreme Court and in a commemorative coloring book. Cash prizes shall be awarded to winners, subject to contest guidelines.
- b) Enclosed in this Memorandum are copies of the official contest guidelines and related issuances from the Supreme Court of the Philippines for reference.
- c) All concerned are enjoined to ensure the wide dissemination of this information through appropriate print and online platforms and to extend the necessary support for the successful implementation of this activity.
