

SUBJECT : **SURVEY ON THE IMPLEMENTATION OF SCHOOL- BASED
FEEDING PROGRAM FOR SY 2025- 2026**

DATE: : February 2, 2026

1. In preparation for the implementation of School- Based Feeding Program (SBFP) for School year 2026- 2027, this Office through the SGOD – School Health Section shall conduct a survey to be answered by all elementary school implementers.
 2. The survey aims to:
 - a. Determine the willingness of schools to provide hot meals to learner-beneficiaries.
 - b. Identify readiness of schools for hot meals implementation.
 - c. Identify the need for additional funds, if any; and
 - d. Obtain the list of schools willing to establish school- based central kitchens.
 - e. Determine acceptability and palatability of NFP commodities delivered to SBFP beneficiary schools.
 - f. Identify NFP products to be served for SBFP SY 2026- 2027 implementation.
 3. The data provided by the schools shall be used for planning and allocation purposes, utilizing both current and continuing funds for SBFP.
