**INVENTORY OF ICT DONATIONS FROM LOCAL GOVERNMENT UNITS (LGUs)
FOR CALENDAR YEAR (CY) 2026**

1. Pursuant to the **Joint Memorandum dated 11 February 2026** from the Office of the Undersecretary for Operations and the Office of the Assistant Secretary for ICT, regarding the *Inventory of ICT Donations from Local Government Units (LGUs) for Calendar Year (CY) 2026*, this Office directs all schools to submit data on ICT equipment donations.
2. The purpose of this inventory is to provide a reliable view of current and projected device availability to guide national budget programming and procurement planning.
3. School Heads and School ICT Coordinators are hereby instructed to account for all ICT device donations from **Barangay, Municipal, City, or Provincial LGU offices** that are:
 - Recently delivered within CY 2026; or
 - Prospective (pledged/planned) for delivery within CY 2026.
4. To facilitate the consolidation by the Division Information Technology Officer (DITO), schools must download the blank template and submit the following details via <https://tinyurl.com/2026LGUDonations> on or before **February 25, 2026**:
 - **Donor LGU:** (e.g., Brgy. San Jose, City Mayor's Office)
 - **Device Type:** (e.g., Laptop, Desktop, Tablet, Printer, Projector, TV/Monitor, Networking Equipment)
 - **Device Count:** Total number of units.
 - **Intended Beneficiary:**
 - i. Learners/Students
 - ii. Teachers
 - iii. School Heads
