1. Please be advised that Days 2 and 3 (June 24–25, 2026) of the field checking, communication, and validation activities for the Basic Education Information System (BEIS) data for SY 2025-2026 have officially commenced.
2. Pursuant to Division Memorandum No. 207, s. 2026, all designated Core Team members are expected to actively review school profile elements, coordinate closely with non-compliant schools, and formally clear accurate profiles for validation to ensure 100% data integrity ahead of the June 30, 2026 deadline.
3. To guarantee 100% operational focus and efficiency during this critical tracking window, all core team members are temporarily relieved from their routine district or school administrative tasks during the designated June 24–25 validation period.
4. Participants are reminded to utilize their own laptops and ensure active access to the master lists, checklists, and unified division tracking sheets provided during the Day 1 orientation.
